As per the orders of the Vice-Chancellor, KNRUHS, Warangal vide 6th cited and as per the Statutes on affiliation of Medical Colleges of Kaloji Narayana Rao University of Health Sciences, Warangal it is hereby certified that the application of the Principal, Dr. VRK Women's Medical College, Teaching Hospital & Research Centre, RR District has been registered with KNRUHS, Warangal and continuation of provisional affiliation is granted for the academic year 2017-18 and permitted to make admissions at Dr. VRK Women's Medical College, Teaching Hospital & Research Centre, RR District with an intake of 100 (One hundred only) seats.

The Institution / College is fully responsible to fulfil the norms and to maintain the same which includes infrastructure both physical and human resource, teaching faculty and clinical material, etc., throughout the academic year, as stipulated in regulations of Medical Council of India.

The number of students admitted shall not exceed the number of students permitted for annual admissions both under University and Management Quota as specified by the Medical Council of India / KNRUHS.

The Fee collected by whatsoever name called either for University quota seats or for management quota seats should not exceed the limits specified by the State Government/Kaloji Narayana Rao University of Health Sciences, Warangal from time to time.

The Management of the College shall follow the regulations made by the University/State Government and also the Graduate Medical Education Regulations 1997 of the Medical Council of India in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice. This order is valid for a period of one year.
